Tansi Kahkewistahaw Citizens,

I hope this newsletter finds you well and in good spirits during this difficult and unsettling time. As a member of Kahkewistahaw's leadership council and your Chief, I am extremely proud of Kahkewistahaw and our ability to come together to respond to the needs of our citizens, no matter where we live. Our nationhood extends beyond our reserve borders and the connections to our homelands remains strong.

Reflecting on the past few months, nationhood and sovereignty have certainly been common themes playing out in many First Nation communities across this country. These developments demonstrate an excellent new level of economic impact our Nation is achieving outside our reserve boundaries. Kahkewistahaw is quickly becoming a major contributor to the overall Saskatchewan economy while establishing our own economy. Each venture is welcomed by both the First Nations and the local municipalities, as we are all facing an economic crisis caused by the COVID-19 shut-down.

Kahkewistahaw is extremely fortunate to be a major player in these high-impact ventures. Recently, at the FSIN's groundbreaking ceremony for their new office complex, I spoke about Economic Reconciliation. Economic Reconciliation is a term that describes a holistic, value-driven approach to First Nation economic opportunities. Opportunities that are built on meaningful and mutually beneficial partnerships or allyships. First Nations are no longer sitting on the sidelines of economic success. First Nations are now an important channel that non-Indigenous business developers seek out, a valued resource necessary for a strong economy.

I believe our Kahkewistahaw Nation is making significant steps towards our own independence and relationship building. However, it takes a team of dedicated and capable people to make it happen. 
KFN Launches Mobile APP for Members

Wright Construction

Our name is Wright Construction and we are thrilled to be the general contractor for the Kahkewistahaw Governance and Administration Centre.

The good weather this summer has led us off to a great start. As for those that have been driving by the site, you can see that we are in full force as structural steel is starting to be erected.

Soon enough there will be floors, wall studs and exterior finishes going on in a push to get enclosed before winter.

Hubert Hwang CFA, Principal, George & Bell Consulting

In 2019, Hubert Hwang of George & Bell Consulting was engaged by Chief and Council to provide advice with respect to the investment of the Kahkewistahaw Legacy Trust. Hubert and his firm will act as the Trust's investment advisor, helping to ensure that the Trust's assets are invested in a prudent manner to create a long-term legacy asset for the First Nation. Over the past several months, Chief and Council, in conjunction with George & Bell and the Trust's other advisors, have worked together to set a long-term policy asset mix for the Trust and have hired two investment managers to manage the Trust's assets. The policy asset mix consists of investments in global stocks, bonds, private loans, and

infrastructure. Approximately 70% of the Trust's assets have been invested to date. Hubert will be responsible for monitoring the Trust's investments and will be providing Council with investment advice on an ongoing basis. You may also see Hubert at future community events where he will be available to provide updates to members.



Des Dumais, Eagle Energy Solutions

I am the business owner of Eagle Energy Solutions Group and have been working in the industry over the past 20 years. I am committed to providing a wide range of skills and services to the Canadian energy industry. My current company partnership with my First Nation community is a design, fabrication and manufacturing facility, in addition to providing cutting edge 3D laser scanning and modelling capabilities.

I am a Kahkewistahaw First Nation band member from south-east Saskatchewan. I have had the pleasure of working as an indigenous entrepreneur during a progressive era for commerce in Canada. I am engaged in helping our community prosper in health and commerce and have served as a bridge to support partnerships between the corporate and First Nation interests.

Coming from humble beginnings, I started working in the energy service sector over 20 years ago. As the industry evolved, so did my interests developing a maintenance and pipefitting company to facilitate energy demands.

Throughout all this learning and expanding, I have been very ambitious to involve and assist my First Nation community in Saskatchewan. In Melville, just a short distance from the community, we have established a fully automated 55,000 sq. ft. fabrication facility. We are excited to provide this opportunity for the region's indigenous and surrounding communities and develop a positive working relationship with Canadian industries partners.

We wanted to share an update with the Melville steel fabrication shop KFN had purchased earlier this year.





This economic business venture is a part of KFN strategic economic plan to bring jobs and training to our members. The fabrication shop, which is located in Melville, will be a fully automated metal fabrication shop.

We anticipate the shop will be fully operational in mid October and we will be hosting a job fair to help fill positions at the end of September.

TD Bank

The Kahkewistahaw First Nation successfully negotiated a settlement with Canada for the Capital & Revenue Mismanagement Claim. In August 2019, \$35,000,000 from this settlement was deposited into the Kahkewistahaw Legacy Trust for the use and benefit of the members of the Kahkewistahaw First Nation.

We were honoured that The Canada Trust Company, a subsidiary of TD Bank, was selected by Chief and Council and appointed as the Corporate Trustee to administer the Trust funds in accordance with the Trust Agreement. Meet the TD representatives: Michelle Samagalski, Charlene Gill and Domenic Natale who are responsible for the day-to-day management of the Trust at the end of this update.

Since being appointed, we have worked with Chief and Council and Stephen Pillipow from SMP Law LLP as legal Advisor for the Trust to select an Investment Consultant. George & Bell Consulting Inc. was hired for this role and with their support, the process of hiring two qualified Investment Management firms that will be responsible for investing and managing the Trust funds has begun.

Chief and Council expressed that we seek out innovative investments to provide stable annual income to support members current needs, as well as grow the value of the Trust over time for the benefit of future members. Working with the Investment Consultant to hire the best Investment Managers to do this, especially during a pandemic, has been challenging but the process is moving forward. So far, one Investment Manager has been hired – Fiera Capital. They are managing 70% of the Trust Funds invested in traditional equity and fixed income portfolios, as well as alternative investments, which are not as sensitive to market volatility. We are in the final stages of hiring a second Investment Manager for the remaining 30% of the portfolio. This is expected to be completed by the end of September 2020.

What does this mean to community members? The Trust has already paid out \$1.2 million from the Trust for use by the Nation, in accordance with its financial laws and policies. Another payment will be made early in 2021 and annually after that. As well, despite the Trust not being fully invested yet and with the unprecedented market volatility during Covid-19, the Trust has increased in value since it was funded one year ago, by over \$1.5 million to \$36,595,000!

In addition to our support on the administration of the trust, TD has also provided financial support and given back to the Nation through sponsorship for requests such as the Kahkewistahaw Pow

We are very excited to share this news, as this has been a focus of our Leadership for the past 2 years, and we look forward to seeing how this new business will help boost employment for our members.

As things progress, we will be giving updates and look forward to our grand opening in November 2020.

Wow. Your TD representatives were looking forward to attending this event in 2020 to meet and speak to community members in person. However, due to Covid-19, and the importance of keeping everyone safe, the event was enjoyed via social media. While not the same experience, we appreciate every opportunity we get to connect.

We wish you all good health and look forward to seeing you in person when it is safe to do so. You will be in our thoughts on Orange Shirt Day, September 30th, as we honour the residential school survivors and their families and demonstrate commitment to our collective journey towards reconciliation.

Ron Maurice, Maurice Law Barristers and Solicitors

MAURICE LAW BARRISTERS & SOLICITORS:

Maurice Law is the first Indigenous-owned law firm in Canada. We advocate for our predominantly Indigenous clientele to achieve justice and work toward reconciliation however each Indigenous community defines it.

Early Years: Maurice Law's roots trace back to 1992, when founding partner Ron Maurice began his career at the newly-established Indian Claims Commission (ICC). Ron was Senior Commission Counsel to the ICC and was involved in 66 public inquiries into many land claims across the country. During his tenure with the ICC, he personally wrote at least 15 inquiry reports and oversaw the drafting of many more as senior counsel. In a number of the claims that had been rejected by Canada, the Department of Justice agreed to reverse its opinion and accept the claim for negotiation based on the legal analysis set out in reports that Ron wrote for the Commission. This included Kahkewistahaw's 1907 Surrender Claim which settled for approximately \$94 million. Ron left the ICC and opened the doors to Maurice Law in 2002, where he was driven by his passion for achieving settlement for the grievances of First Nations in Canada.

Today: Maurice Law is a small firm that is rapidly growing. The most substantial aspect of our practice is advising and advocating for our First Nations clients in Canada's Specific Claims process. Our team of lawyers has extensive experience acting for our clients across Canada in pursuing claims under Canada's Specific Claims Policy and for advocating on behalf of our clients at the Specific Claims Tribunal. We understand the importance of community. Our team works closely with community Elders and experts to inform the historical record and speak to losses felt by the community as a result of Crown action or inaction.

Maurice Law has four key values:

- Access to justice: First Nations have a fundamental need to have access to justice without having to expend limited resources to do so. Thus, Maurice Law established an insurance and financing program for claims being pursued through Canada's Specific Claims Process. This program has since become pivotal for our client's efforts in seeking redress in relation to historical wrongs concerning their land and the promises made to them by Canada under Treaty.

- Persistence: Maurice Law believes in persistence. We are open to negotiation in good faith, but always prepared to advocate.
- Multidisciplinary approach to legal issues: Maurice Law values the importance of historical research and uses historical facts to take emotionally charged situations and turn them into fair results.
- Creation of community legacies: After Maurice Law secures an award or settlement for its clients, we encourage clients to think about the future of their communities through the creation of legacies that will navigate the management of their settlements and awards and protect the rights of future generations.

KAHKEWISTAHAW'S SPECIFIC CLAIMS:

Maurice Law represents the Kahkewistahaw First Nation on two Specific Claims:

(1) Specific Claims Tribunal – Flooding Claim: Maurice Law is currently working on a “flooding” claim for the Kahkewistahaw First Nation. The Flooding Claim concerns flooding and damages to Kahkewistahaw reserve land as a result of the Crown’s actions over the years, primarily by the negligent operation of the Round Lake and Crooked Lake dams. This has permanently altered and disrupted the natural flow and meander of the Qu’Appelle River system.

(2) Specific Claims Branch—Agricultural Benefits Claim: The second claim is the “agricultural benefits” claim. Maurice Law currently acts for a number of First Nations with similar claims, three of which are presently before the Specific Claims Tribunal. Agricultural benefits claims are based on the Crown’s historical failure to provide agricultural benefits owed to First Nation groups under Treaty No.4. Agricultural benefits would include articles such as tools, implements, seed, and livestock that would have helped to facilitate a smoother transition into agricultural livelihood. In failing to provide those benefits, the Crown breached its Treaty obligations.

Crooked Lake and Round Lake Control Structures and Flooding of IR 72

Prior to the flooding caused by the dams, the lands along the Qu’Appelle River were naturally irrigated and well-suited for the production of hay which supported the Band’s horse and livestock industry.

Angus Vincent, Human Resource Manager

Angus Vincent is the Human Resource Manager for Kahkewistahaw First Nation.

“I’m very excited for this new role, and I’m looking forward to working with the Kahkewistahaw team and getting to know the community,” he says.

Vincent is a member of the Waterhen Lake First Nation in northern Saskatchewan, and currently calls Yorkton home. He is married with two children, and loves camping and golfing in the summer and spending time in the arena during winter.



Tyler Jones, Housing Director

Tyler Jones is the Kahkewistahaw housing director.

“Along with my team of professionals, I’m excited to bring the band’s housing to a new standard, and to bring forth growth for all of our members’ benefit,” he says.

Jones is a Kahkewistahaw First Nation member and is a red seal journeyman carpenter with six years of experience in affordable urban housing for First Nations people. He previously served as the maintenance director for Silver Sage Housing in Regina.

Construction Underway for New KFN Governance and Administration Centre

Chief and Council are pleased to report the Governance and Administration Centre construction is well underway. The Centre is being built with the assistance of SAL Engineering Ltd., Consultants Aodbt architecture + interior design and contractor Wright Construction Western Inc.

The Governance and Administration Centre will have a combined area of 3,300 m² over two stories. The facility will include office spaces, boardrooms, multi-purpose areas, kitchen, fitness centre, daycare, Health Centre, and a museum area. The facility will also have a 100 kW solar field.

Chief Evan Taypotat says, "The facility will be a state of the art centre with much needed space and quality workspaces and community use areas. We should all be proud of this accomplishment."

The Governance and Administration Centre started construction in June 2020 and is projected to be completed in the fall of 2021.

Wright Construction is currently working on site development and construction of the foundation of the facility.

Wright Construction and the Project Management Team has proudly held a job fair in July of 2020 to initiate the use of local

labour on this project. The Project has

already begun utilizing KFN members and will continue to provide opportunities throughout construction.

We want to thank everyone who has been involved in the Project and look forward to the completion.
